
5:30pm - Memorial Tree Dedication - to be held at the neighborhood mailboxes

Community Concerns



Poo Reports:

Many Arbors residents own dogs and walk those dogs through the common areas.

Unfortunately, some residents are not picking up after their pets. We have had "poo" reports about waste on lawns.

There is no other way to put it:

This is a disgusting, insensitive, and potentially unhealthy practice.

Often, daily newspapers are delivered in a long, narrow plastic bag. If these are saved, and if there are no holes in them, they provide a handy way to pick up after your pet. Slip your hand into the bag, pick up the offending substance, pull the bag off your hand turning it inside out so the poo ends up inside the bag which can then be neatly tied. Collect these bags throughout the week, put them all into another small bag (perhaps one from the grocery store), and throw the collection into your trash can. That's it!

Pet ownership is a privilege. Please don't abuse it to the detriment of the neighborhood.

Parking Pad Rule:

The Arbors Association Executive Board has decided to issue parking permits for your guests. In the past we have had unidentified vehicles using the guest parking locations. To eliminate confusion the Board agreed it would be best to issue a sign that can be placed in your guest's car window while parking on the property. Each homeowner has been issued 6 parking permits. Rule #9:

No vehicle shall be parked in such a manner as to impede or prevent ready access to any entrance to or exit from any Building, or the parking areas and ramps by another vehicle. Residents are not permitted to park on the street longer than (2) hours. Residents' guests are permitted to park on the street temporarily but not overnight. Off street parking areas are strictly intended for guest parking. Each Unit is not permitted to have more than three (3) permanent vehicles located on or within said Unit's designated parking area. Residents must park their vehicles in their own garages and driveways. Residents must provide their overnight guests with a parking permit to display in their front window while parked in the guest parking lots.

Exterior Maintenance

There are some areas of your unit exterior that is the responsibility of the homeowner. Please make it a priority to keep these items in good shape to uphold the standards of your neighborhood. Items such as:

Lights	burnt out bulbs should be replaced promptly & globes should be maintained
Windows	should be maintained and repaired if damaged
Decks/ Patios/ Porches	should be maintained, repaired if damaged, and free of clutter
Front Doors	should be maintained (to include staining) and repaired if damaged

The Common Elements Committee has arranged for the following services to be offered to each homeowner at a lower rate if done all together:

Front Door Staining - R J Brubaker Painting quoted \$125.00 for the exterior of the front door and \$50.00 for the interior of the front door. If you wish to proceed contact Michelle at (717) 293-0293 ext. 131 or email michelle@millfield.com by April 30th.
